The Market Surveillance Administrator (MSA) is a public agency that protects and promotes the fair, efficient, and openly competitive operation of Alberta's electricity and retail natural gas markets. The MSA conducts surveillance of Alberta's electricity and retail natural gas markets and undertakes enforcement activities to ensure compliance with all applicable electricity and natural gas legislation, the Alberta Reliability Standards, and the Independent System Operator's rules.

The MSA's work is carried out by a small group of highly trained economists, analysts, and legal and administrative staff. If you are looking for a challenging and collegial environment where everyone's contribution counts, the MSA welcomes you to our team. CAREER OPPORTUNITY

The MSA is looking to recruit a Senior Analyst, Compliance. The Senior Analyst, Compliance will have the following responsibilities:

- Review and assess events and information relating to suspected contraventions of Alberta Reliability Standards and technical ISO rules;
- Provide recommendations regarding enforcement outcomes;
- Prepare written enforcement dispositions;
- Learn and apply lessons and experience from organizations similar to the MSA in other electricity markets;
- Liaise with counterparts at the Alberta Electric System Operator, Alberta Utilities Commission, and market participant organizations to identify and resolve issues.

To complete this work successfully, the Senior Analyst, Compliance will work individually and as part of teams to support the MSA's mandate relating to Alberta Reliability Standards and ISO

rules enforcement. They will be expected to develop and execute analytical frameworks, methodologies, and work plans that are appropriate to their assigned tasks and to present and actively seek feedback regarding the results and implications of their work. They will also be expected to assist, guide, and train others to perform complex assignments. Active project management and the ability to prioritize competing demands will be essential for success in the position.

The Senior Analyst, Compliance will report to the Director, Compliance.

QUALIFICATIONS

- Bachelor's or Master's degree relating to engineering, power systems, information systems, information security, computer science, or other quantitative discipline.
- 5 or more years of prior professional experience in a compliance, audit, technical, or quantitative role relating to power system operations, cyber security, planning, modelling, protection and control, or risk management.
- Demonstrated experience with Alberta Reliability Standards or NERC Reliability Standards.
- Direct knowledge of the interconnected electric system in Alberta is an asset.
- Demonstrated ability to evaluate complex data to test hypotheses, apply and adapt frameworks, evaluate results, and draw and present conclusions.
- Demonstrated experience with statistical and / or data management software. Advanced Microsoft Office skills are essential.
- Strong written and oral communications skills, including the ability to effectively present information to colleagues, management, industry professionals, and public groups, including writing reports and making presentations.
- Ability to work effectively individually and on teams and under inflexible time constraints.
