ISO rule 203.4 indicates that if an operational deviation extends for twenty minutes or longer, the pool participant must submit an available capability or MW restatement for the asset that represents the operational capability of the asset no longer than twenty minutes after the start of the operational deviation. **FINDINGS** Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 203.4.
