EVENT DETAILS			
On May 20, 2016 during HE 12, the ENCG asset was dispatched to provide 16 MW of supplemental reserves load (SUPL). At 11:22 ENCG received an ancillary services directive to reduce load by 16 MW. Between 11:22 and 11:32, ENCG reduced load by 12 MW; 4 MW less than the directed amount. ISO rule section 205.6 indicates that a pool participant must ensure that after receiving a directive to provide supplemental reserve, the asset is providing the quantity of real power equal to the instantaneous amount of real power of the asset at the time of the directive plus the amount of real power set out in the directive, no later than ten minutes after receiving the directive.			
FINDINGS			
Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 205.6.
