Information available to the MSA indicated that the 10:42 restatement could have been submitted prior to T-2 and therefore was not submitted as soon as reasonably practicable. Information available to the MSA also indicated that a restatement of AC alone could have accommodated the AFG1 asset's operating state. ISO rule section 203.3 indicates that if there is a change in AC of the source asset, the pool participant must restate AC as soon as reasonably practicable. Rule section 203.3 also indicates that if a source asset cannot comply with a current offer due to an acceptable operational reason, a MW restatement to represent a change in the operating state of the source asset may only be used if an available capability restatement cannot reasonably accommodate the source asset's operating state. **FINDINGS** Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 203.3. **MATERIAL FACTS** The material facts relied upon by the MSA include the following: AESO energy offer, available capability, and acceptable operational reason data for AFG1 for July 2, 2016.
