On November 27, 2016 at approximately 19:31, ANC1 restated its available capability (AC) down from 63 MW to 57 MW for the entirety of November 28, 2016 with the reason "Derate - Forced - remove/repair combustion probes engine 10". While the operational status of ANC1 remained unchanged into and during November 29, 2016, AC was not revised accordingly until approximately 07:15 on that day. ISO rule section 203.3 indicates that if there is a change in AC of the source asset, the pool participant must restate AC as soon as reasonably practicable.			
FINDINGS			
Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO Rule 203.3.

The material facts relied upon by the MSA include the following: 1. AESO energy offer, available capability, and acceptable operational reason data for ANC1 for November 27 through 29, 2016. 2. Self-report from Alberta Newsprint Company to the MSA dated December 1, 2016.
