EVENT DETAILS

On May 17, 2017 at 19:24 the ENNE asset was directed to provide 5 MW of supplemental reserve. ENNE did not provide a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive plus the amount of real power set out in the directive within ten minutes after receiving the directive. Subsection 7(1) of section 205.6 of the ISO rules states:

A pool participant must, within ten (10) minutes after receiving a directive to provide supplemental reserve, ensure that the pool asset is providing a quantity of real power equal to the instantaneous amount of real power of the pool asset at the time of the directive plus the amount of real power set out in the directive, as measured in accordance with subsection 3(3).

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 205.6. Pursuant to s. 4.2(b) of the Alberta Utilities Commission (AUC) Rule 019, the MSA has issued five or more notices of specified penalty in relation to the EnerNOC Ltd. ENCG asset, therefore the above specified penalty amount is assessed at a fifth or subsequent level as prescribed in s. 4.3 of AUC Rule 019 less the applicable self-reporting reduction.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO generation and directive data for ENNE for May 17, 2017.
2. Self-report submitted by EnerNOC Ltd. to the MSA dated June 16, 2017.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
