EVENT DETAILS

Between approximately 19:42 and 20:11 on May 8, 2017, generating asset SCR4 received seven dispatches, six of which timed out without acknowledgement. Subsection 5 of section 201.7 of the ISO rules states, in part:

A pool participant must acknowledge receipt of a dispatch:

- (a) in the case of an automated message and unless the pool participant has notified the ISO of an unavailability in accordance with subsection 4(1)(a) by responding via the Automated Dispatch and Messaging System:
 - (i) within two (2) minutes for an intra-Alberta transaction;

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of ISO rule 201.7.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO dispatch data for SCR4 for May 8, 2017.
2. AESO information request issued to Oldman 2 Wind Farm Limited dated August 16, 2017.
3. Oldman 2 Wind Farm Limited's response to the AESO information request dated September 8, 2017.
4. Referral from the AESO to the MSA dated October 5, 2017.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
