## **EVENT DETAILS**

Throughout March 11, 2022, the BUR1 asset was in receipt of multiple transmission constraint directives beginning at approximately 09:39. Information available to the MSA indicates that BUR1 did not comply with all directives received. Section 301.2 of the ISO rules states, in part:

3(1) A market participant must comply with a directive it receives subject to any other ISO rule or reliability standard and the exceptions in subsections 3(2) and 3(3).

#### **FINDINGS**

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 301.2 of the ISO rules.

### **MATERIAL FACTS**

The material facts relied upon by the MSA include the following:

- 1. AESO dispatch, directive, and generation data for BUR1 for March 11, 2022.
- 2. Self-report submitted by Yellow Lake & Burdett Solar LP to the MSA dated April 10, 2022.

## NOTICE
