EVENT DETAILS

Information available to the MSA indicates that there were instances between November 21, 2017 and April 10, 2022, where the various generating units that make up the SCL1 asset exceeded their maximum authorized real power. Section 502.6 of the ISO rules states in part:

5(1) The operator of a generating unit must not operate the generating unit above its maximum authorized real power.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 502.6 of the ISO rules.

- 1. AESO generation data for SCL1 for November 21, 2017 through April 10, 2022.
- 2. Self-report submitted by Syncrude Canada Ltd. to the MSA dated May 3, 2022.
- 3. Additional information provided by Syncrude Canada Ltd. to the MSA dated May 17, 2022 and February 23, 2023.
