### EVENT DETAILS

During settlement intervals HE 07 and 24 on September 13, 2022, Canadian Hydro Developers, Inc. offered to provide approximately 10 MW of Fast Frequency Response (FFR) from its SUM1 asset, while the SUM1 asset was contracted to provide 10 MW of supplemental reserve (SUP). Information available to the MSA indicates that the SUM1 asset would not have been able to comply with all FFR and SUP dispatches given the maximum capability (10 MW) of the asset. Section 201.4 of the ISO rules states in part:

5 A pool participant must coordinate its submissions in a manner that ensures the pool participant is able to comply with all dispatches related to those submissions.

### FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 201.4 of the ISO rules.

### MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. AESO maximum and available capability, dispatch, generation and offer data for SUM1 for September 13, 2022.
2. AESO information request issued to Canadian Hydro Developers, Inc., dated October 19, 2022.
3. Canadian Hydro Developers, Inc.'s response to the AESO information request, dated November 1, 2022.
4. Referral from the AESO to the MSA dated November 30, 2022.

### DELIVERY OF PAYMENT

### NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
