EVENT DETAILS

For the HE 04 settlement interval on January 28, 2023, Powerex Corp. declared an export bid of 300 MW for the PW20 asset two hours prior to the start of the settlement interval. Applicable e-tag(s) were not received by the ISO twenty minutes prior to the start of the settlement interval. Section 203.6 of the ISO rules states, in part:

6(1) Pool participants with any import or export interchange transactions who have acquired transmission service must submit e-tags to the ISO for the interchange transactions.

(2) The ISO must receive e-tags no later than twenty (20) minutes prior to the start of the settlement interval in order for the energy components of the interchange transactions to be included in an interchange schedule referenced in subsection 8.

FINDINGS

Based upon the information obtained by the MSA, the MSA is satisfied that the event was a contravention of section 203.6 of the ISO rules.

MATERIAL FACTS

The material facts relied upon by the MSA include the following:

1. Interchange data and AESO bid data for PW20 for January 28, 2023.
2. Self-report submitted by Powerex Corp. to the MSA dated February 7, 2023.

DELIVERY OF PAYMENT

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5(1) of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
