MSA FINDINGS

Information available to the MSA indicates that the GRZ1 asset was undergoing commissioning in December 2022 and January 2023. For the dates December 17, 2022 HE 01 through December 25, 2022 HE 24, and December 27, 2022 HE 01 through January 17, 2023 HE 24, offers were submitted for the GRZ1 asset such that the price was greater than zero dollars. Section 203.1 of the ISO rules states in part:

4 Notwithstanding subsection 3(3)(a)(i), a pool participant that submits an offer for a generating source asset which is undergoing commissioning and testing under section 505.3 of the ISO rules, Coordinating Synchronization, Commissioning, WECC Testing and Ancillary Services Testing must, until the ISO otherwise authorizes in writing, submit a price for the offer of zero dollars (\$0).

The MSA is satisfied that the conduct was a contravention of section 203.1 of the ISO rules.

NOTICE

The Market Surveillance Administrator (MSA) is granted the power and authority under s. 52 of the *Alberta Utilities Commission Act* to issue a Notice of Specified Penalty where the MSA is satisfied that a person has contravened an ISO rule. Specified penalties are set out in AUC Rule 019.

In accordance with the relevant enactments and rules, a dispute regarding the issuance of a Notice of Specified Penalty or failure to pay the specified penalty in accordance with this notice will result in a hearing or other proceeding before the AUC.

In accordance with s. 5.1 of AUC Rule 019 this Notice of Specified Penalty will be made public no earlier than receipt of confirmation of payment from the Commission and no later than 45 days after issuance. The MSA will, if applicable, also post on its website the link to any decision of the AUC respecting the specified penalty.
